I have read and understand that I will be disqualified and prohibited from serving as a coach/volunteer of Lenoir City Parks and Recreation if I check YES to any of the following:

- YES NO I have been convicted of a criminal offense. (excludes minor traffic violations).
- YES NO I have been convicted (includes crimes of record which have been expunged and pleas of "no contest") of a crime of child abuse, sexual assault of a minor, physical abuse, causing a child's death, or neglect of a child. Murder, manslaughter, felony assault or any assault against a minor. Kidnapping, arson, criminal sexual conduct, prostitution related crimes, controlled substance crimes or any felony.
