Mayor Tony Aikens asked for comments from citizen regarding an item/items on the agenda.

A motion was made by Johnson and seconded by Shields to approve the minutes of the April 9, 2018 meeting. The following vote was recorded: Henline, Hines, Johnson, Shields, and Wampler voting **AYE**. Simpson was absent.

A motion was made by Johnson and seconded by Shields to approve the permanent, full-time employment for Cole Morgan, after satisfactorily completing his six (6) months with the Police Department. The following vote was recorded: Henline, Hines, Johnson, Shields, and Wampler voting **AYE**. Simpson was absent.

A motion was made by Shields and seconded by Johnson to approve the permanent, full-time employment for Brad Rayfield, after satisfactorily completing his six (6) months with the Police Department. The following vote was recorded: Henline, Hines, Johnson, Shields, and Wampler voting **AYE**. Simpson was absent.
