The City Council of Lenoir City met in its regularly scheduled meeting at 6:00 P.M. Mayor Aikens and the following Councilmen were present: Henline, Hines, Johnson, Simpson, and Wampler. Gregory Harrison, Amber Scott, and Maggie Hunt were also present. Councilman Shields was absent.

Mayor Aikens asked for comments from citizen regarding an item/items on the agenda.

A motion was made by Henline and seconded by Johnson to approve the minutes of the July 9, 2018 meeting. The following vote was recorded: Henline, Hines, Johnson, Simpson and Wampler voting **AYE**. Councilman Shields absent.

A motion was made by Simpson and seconded by Wampler to add agenda Item #5 to extend the TDOT contract for the Harrison Road Project to October 31, 2018. The following vote was recorded: Henline, Hines, Johnson, Simpson and Wampler voting **AYE**. Councilman Shields absent.

A motion was made by Simpson and seconded by Henline to add agenda Item #6 to hire an employee for the Fire Department, Jeremy Rogers. The following vote was recorded: Henline, Hines, Johnson, Simpson and Wampler voting **AYE**. Councilman Shields absent.
