The City Council of Lenoir City met at the Highland Park Ruritan Club in its regularly scheduled meeting on Monday, April 8, 2019 at 6:00 P.M. Mayor Tony Aikens and the following Council Members were present: Hines, Shields, Simpson, Wampler, and Brandon. Amber Scott, Gregory Harrison, James Wilburn and Maggie Hunt were also present. Councilman Johnson was absent.

A motion was made by Shields and seconded by Brandon to approve the minutes of the March 25, 2019 meeting. The following vote was recorded: Hines, Shields, Simpson, Wampler, and Brandon **AYE**. Johnson Absent.

Mayor Tony Aikens asked for comments from citizens regarding an item/items on the agenda.

A motion was made by Wampler and seconded by Shields to approve an Ordinance to amend the Zoning Map of The City of Lenoir City, Tennessee Pursuant to 13-7-204 of The Tennessee Code Annotated to rezone property located at 6068 Highway 70 East, 8998 Creekwood Park Boulevard, and certain parcels off Creekwood Park Boulevard from R-4 Residential District to C-3 Highway Commercial District. The following vote was recorded: Hines, Shields, Simpson, Wampler, and Brandon **AYE**. Johnson Absent.

A motion was made by Shields and seconded by Wampler to award the bid to Landmark International Trucks for the purchase of one (1) Diesel Dump Truck with 16ft bed as part of TDOT PM 2.5 Diesel Grant.(1) Landmark International Trucks -\$103,113.20. The following vote was recorded: Hines, Shields, Simpson, Wampler, and Brandon **AYE**. Johnson Absent.

A motion was made by Simpson and seconded by Brandon to award the bid to Landmark International Trucks for purchase of three (3) Diesel Dump Trucks with 10 ft rock bed as part of TDOT PM 2.5 Diesel Grant.(1) Landmark International Trucks - \$271,135.40. The following vote was recorded: Hines, Shields, Simpson, Wampler, and Brandon **AYE**. Johnson Absent.

A motion was made by Brandon and seconded by Wampler to award the bid to Lenoir City Ford for purchase of two (2) One-Ton Diesel Dump Trucks as part of TDOT PM 2.5 Diesel Grant. (1) Lenoir City Ford- \$85,128.60. The following vote was recorded: Hines, Shields, Simpson, Wampler, and Brandon **AYE**. Johnson Absent.


